Significant revenue and expense variances that exceed \$100,000 and 5% of line item budget at the end of May 31, 2022 are explained as follows:

REVENUE

Autism: Under budget by \$4,684,135 or 17%

 Revenue is recorded based on actual expenses for eligible individuals and services. The number of people served in the first and second quarter of FY 2022 has dropped by about 50 people. This decrease has resulted in less cost.

Grants: Under budget by \$2,747,258 or 22%

 \circ See the detail on the expenditure section below.

Local Revenue: Under budget by \$852,968 or 13%

 Local revenue is under budget because the collections of service revenue to Medicare, commercial payers and other counties is less than expected. This is due to fewer services provided to individuals funded by these paying sources. One reason is slower ramp up in the CCBHC expansion program than initially expected.

EXPENDITURES

Direct Run: Under budget by \$2,216,352 or 10%

• There are many open positions across the organization. The departments most impacted are Mobile Crisis, Supports Coordination, ACT, and Integrated Case Management.

Grants: Under budget by \$2,477,388 or 20%



Management requests Board approval for the Executive Director to enter into agreement with Trinity Health-Saint Marys and Hegira Health Inc. Also, to amend the contract with Family Outreach Center for Jail Mental Health Services.

Description/Purpose	Amount
Trinity Health-Saint Marys contract is for preconstruction costs incurred for the new Crisis Services Unit. These preconstruction costs will be covered with COVID-19 block grant funding thru MDHHS.	\$85,000
Hegira Health, Inc. (Wayne County) was selected thru a request for applications to find an appropriate agency to provide services utilizing the evidence based NAVIGATE model for providing services. After discussing this funding opportunity with several organizations Hegira Health was the only organization to apply. The FY 22 funding will allow Hegira to have staff in place in FY 23 with funding for a full year in FY23. The funding source for this program is Early onset Psychosis Set Aside COVID-19 Comprehensive Services for Behavioral Health-2022 (American Rescue Plan) thru MDHHS.	\$72,882 (FY 22)
Family Outreach Center contract is being amended to increase the allowable salaries for staff to ensure Jail Mental Health Services is fully staffed. The annual increase is \$190,079 funded 50% by Kent County and 50% General Fund.	\$47,520 (FY22)
Family Outreach Center contract to build upon an existing Seeking Safety group which focuses on black and brown men, and expanding it to women/girls with American Rescue Plan Act funding (ARPA) thru LRE.	\$100,000

COVID-19

As of July 8th, the seven-day average for Kent County is down to 106 cases per day that is a decrease of 21 cases per seven-day average from last month. Network180 has removed its mask mandate for all non-clinical areas. Network180 is maintaining its mask mandate for all clinical areas in accordance with CDC guidelines. Network180 continues to monitor COVID-19 and will adjust protocols depending on transmission rates od COVID-19.

Lakeshore Regional Entity (LRE)

In May of 2022, the LRE has asked each of the five Community Mental Health Service Programs (Allegan, Kent, Muskegon, Ottawa, and West Michigan) to consider Bylaw changes and a new Operating Agreement for the LRE. On June 27th the Board of Directors met with the LRE CEO and the LRE Counsel along with Network180's Counsel to consider the recommended changes to the LRE bylaws and Operating Agreement. Through Network180's Counsel it was determined that the controlling Bylaws were in fact the 2016 LRE Bylaws not the 2018 LRE Bylaws, which vested the power to change Bylaws with the LRE Executive Committee not individual CMHs. Therefore, the only question before the Network180 Board of Directors is to nominate a delegate to the LRE Executive Committee for the purposes of deliberation and ultimately casting a vote on behave of Network180. Network180's Board of Directors will consider that nomination at its Board of Directors meeting on July 11th.

Michigan Legislature and Fiscal Year 2023 Budget

In a marathon legislative session on June 29th and June 30th both Chambers (MI House and MI Senate) passed the FY2023 Budget at 3:00am on June 30th. Below is a summary of the Mental Health Budget for 2023:

Other Highlights of the FY23 Final Budget:

- Included \$101.2 million for CCBHC
- Included \$61.3 million for Health Homes to increase the number of behavioral health homes from 37 to 42 and the number of opioid health homes from 40 to 49.
- Included Opioid Settlement Fund (\$23.2 million Gross)
- Local match drawn down phase out \$5 million GF (brings to year 3 of 5-year phase out)

Direct Care Worker Wage Increase and Report

Sec. 231 Requires DHHS to increase wages by up to \$2.35 per hour paid to direct care workers funded by DHHS appropriations, and states specific workers and wage increases to be supported. Includes provisions if a worker elects to reject the increase. Requires contractor quarterly reporting and requires DHHS to report by March 1 including details on wages paid.

Conference concurs with the House, and <u>changes contractor reporting to annual, removes</u> <u>the market rate survey, and includes minor edits.</u>

House original recommendation: revises to require Medicaid managed care organizations of MI Choice, MI Health Link, and PIHPs to continue the direct care wage increase and to report quarterly to DHHS on direct care salaries paid, require DHHS to perform a market rate survey, and remove references to private child caring institutions, area agencies on aging, and long-term care (which is moved to new Sec. 1644).

Michigan Crisis and Access Line (MiCAL)

 Conference concurs with the House and adds \$3.0 million GF/GP to continue to MiCAL statewide, a behavioral health crisis intervention and support call center and also provides primary coverage in regions where a regional national suicide prevention 988 lifeline center does not provide coverage and for statewide secondary coverage for 988.

Opioid Healing and Recovery Fund

 Conference includes \$23.2 million based on updated settlement amounts of restricted funds from court settlements between the state and opioid manufacturers and distributors.

Families Against Narcotics (FAN)

Conference includes \$5.0 million GF/GP on one-time basis.

Court-Appointed Guardians

 Conference includes \$5.0 million to reimburse CMHSPs for the cost of court appointed public guardians.

Medicaid Methadone Bundled Services Rate Increase

 Conference adds \$16.2 million Gross (\$4.1 million GF/GP) based on updated cost estimates to increase the Medicaid bundled reimbursement rate for administering and servicing methadone to \$19.00.

Behavioral Health Inpatient Capacity and Operations

 Conference includes \$41.0 million GF/GP and authorizes 87.0 FTE positions to increase capacity at Hawthorn and to reimburse private providers of intensive psychiatric treatments.

New Non-State Behavioral Health Facility Capacity

Conference adds \$170.6 million GF/GP for House items listed above, \$50.0 million for competitive pediatric psychiatric infrastructure grants, \$5.0 million for Detroit Children's Hospital psychiatric, and \$2.5 million for Insight Behavioral Health in Flint. (Complete list of projects on pages 673-678 of the budget bill)

- Pine Rest pediatric behavioral health center (\$38.0 million)
- Detroit Wayne Integrated Health Network psychiatric campus (\$45.0 million)
- Establishing crisis stabilization units (CSUs) (\$32.0 million)

• Conference concurs with the Executive and includes a net increase of \$1.1 million GF/GP and authorizes a net 8.0 FTE positions to increase administrative support for admission and discharges, the Michigan Community Transition Program, and Psychiatric Residential Treatment Facilities.

Boilerplate Items

<u>Sec. 908. Uniform Community Mental Health Credentialing</u> – RETAINED States that contracts with PIHPs and CMHSPs must work toward implementing section 206b of the Mental Health Code on uniform community mental health services credentialing.

<u>Sec. 912. Salvation Army Harbor Light Program</u> – RETAINED Requires DHHS to contract with the Salvation Army Harbor Light Program for providing non-Medicaid substance use disorder services, if program meets standard of care.

<u>Sec. 924. Autism Services Fee Schedule</u> – REVISED Requires DHHS to maintain a fee schedule for autism services by not allowing expenditures used for actuarially sound rate certification to exceed the identified fee schedule, also sets behavioral technician fee schedule at not less than \$50.00 per hour and not more than \$55.00 per hour. <u>Conference changes hourly rates to \$52.35 and \$57.35.</u>

<u>Sec. 927. Uniform Behavioral Health Service Provider Audits</u> – RETAINED Requires DHHS to create a uniform community mental health services auditing process for CMHSPs and PIHPs, outlines auditing process requirements, and requires a report.

<u>Sec. 960. Autism Services Cost Containment</u> – RETAINED Requires DHHS to continue to cover all autism services that were covered on January 1, 2019; to restrain costs required DHHS to develop written guidance for standardization; and requires 3-year reevaluations, unless a clinician recommended an earlier reevaluation, and require maintenance of statewide provider trainings, limits practitioners who can perform a diagnostic evaluation and requires evaluations performed by a master's level practitioner to be reviewed by a second practitioner, provide fidelity reviews and secondary approvals, and prohibit specific providers from providing both evaluation and treatment; requires a report.

<u>Sec. 970. Skill Building Assistance Services</u> – REVISED Requires DHHS to maintain skill building assistance services policies in effect on October 1, 2018 and requires DHHS to continue to seek federal matching funds for skill building assistance services. <u>Conference make</u> technical revisions.

<u>Sec. 1062. 5-Year Inpatient Psychiatric Bed Plan</u> – DELETED Requires DHHS to report a 5-year plan to address need for public and private inpatient psychiatric beds for adults and children.

The Michigan Department of Health and Human Services budget contained \$32 million dollars of onetime funding for the establishment of Crisis Stabilization Units (CSU) which is part of Network 180 Crisis Continuum plan of action. Network 180 has been assured by the Michigan Legislature that Network 180 will have access to these funds for the establishment of the new CSU which will be operated in conjunction with Saint Mary's Trinity Health at its downtown location. The Legislative session was adjourned with no action taken on either the MI House or MI Senate mental health reform bills. These initiatives will most likely see some movement this fall when the legislature returns after the summer recess.
